

**PETITION FOR A CHARTER AMENDMENT TO  
CHANGE THE BOUNDARIES OF THE CITY OF FREDERICK, MARYLAND**

Each person signing below represents that the person is registered to vote and a qualified voter in the City of Frederick and petitions to have the Charter Amendment set forth below placed on the ballot in the next regular municipal general election or at a special election, in the discretion of the Mayor and Board of Aldermen.

The Charter Amendment would change the City boundaries to exclude certain land that had been made part of the City by annexation, specifically:

- De-annex approximately 285 acres known as the Crum Farm property and approximately 151 acres known as the COPT/Thatcher property. These properties were annexed by Resolution No. 09-18 and Resolution No. 09-19, approved and passed on 9-4-09 by the Mayor and Board of Aldermen of the City. - The Charter Amendment would change Charter Article I, Incorporation and General Government, Section 2 Boundaries, by adding the words in italics to read as follows:

The corporate boundaries shall be described by a system of courses and distances based on the coordinate system established by the Bureau of Control and Surveys of the State of Maryland. An accurate written description of the current boundaries of the City shall be kept on permanent file in the Office of the City Engineer. *The corporate boundaries do not include land annexed by Resolutions 09-18 and 09-19.*
